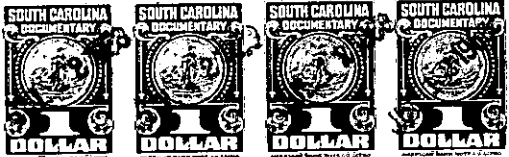

An undivided one-half interest in and to the following described property:

ALL that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, on the Northeastern side of East Welborn Street, near the City of Greenville, being shown as Lot #56 on plat of Anderson Street Highlands made by Dalton and Neves in 1939, recorded in the R.M.C. Office for Greenville County in Plat Book "J", at Page 157, and described as follows:

BEGINNING at a stake on the Northeastern side of East Welborn Street, 512.5 feet Southeast from Anderson Road at corner of Lot #57, and running thence with the line of said lot, N. 42-40 E. 150 feet to a stake at corner of lot #71; thence with the line of said lot, S. 47-20 E. 50 feet to a stake at corner of Lot #55; thence with the line of said lot, S. 42-40 W. 150 feet to a stake on East Welborn Street; thence with the Northeastern side of East Welborn Street, N. 47-20 W. 50 feet to the beginning corner.

This is the identical property conveyed to the late J. H. Nesbitt and Lennie Annie Nesbitt by deed of William J. McIntyre recorded in Deed Book 360, at page 387, R.M.C. Office Office for Greenville County. The said James H. Nesbitt died testate on May 5, 1959 owning an undivided one-half interest in said property and under the terms of the Will of the said James H. Nesbitt, the Grantor herein was given full power and authority to convey said property. Reference is hereby made to the estate records of the said James H. Nesbitt on file in Apartment 707, File 22 in the Office of the Probate Court for Greenville County.
