

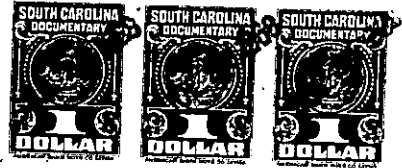

BEGINNING at an iron pin on Warehouse Court at joint front corners of Lots 7 and 8 and running thence along the line of said lots, S. 4-00 W. 178.8 feet to an iron pin; thence running with line of Lot 79, S. 86-0 W. 50 feet to an iron pin at rear corner of Lot 9; thence running with line of said lot, N. 4-00 E. 183.4 feet to an iron pin on Warehouse Court; thence running with said Warehouse Court, S. 88-43 W. 50.2 feet to the beginning corner.

ALSO: ALL that piece, parcel or lot of land in the County of Greenville, State of South Carolina, in Chick Springs Township, being shown and designated as Lot 9 on map of Lincoln Town, Paris, prepared by Dalton & Neves, June 1945, recorded in Plat Book "S" at Page 39, and described as follows:

BEGINNING at an iron pin at the corner of Wynette Avenue and Warehouse Court and running thence with the western side of Wynette Avenue, S. 4-00 W. 188 feet to an iron pin at the joint corner of Lots 9 and 79; thence with the line of Lot 79, N. 68-0 W. 50 feet to an iron pin, joint corner of Lots 8 and 9; thence with the line of Lot 8, N. 4-00 E. 183.4 feet to an iron pin on the southern side of Warehouse Court; thence with Warehouse Court, N. 88-43 E. 50.2 feet to the beginning corner.
