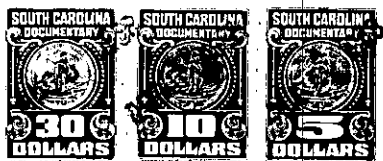
KNOW ALL MEN BY THESE PRESENTS, that we, C. S. Mattox and Wilson M. Dillard -----
