to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said grantee(s)

WILLIAM C. JOHNS AND HATTIE P. JOHNS, THEIR HEIRS AND ASSIGNS, FOREVER:

All that certain piece, parcel, or lot of land in the County of Greenville, State of South Carolina, on the southerly side of Maria Louisa Lane, being shown and designated as Lot No. 11, on plat of Dellvista Heights, recorded in the RMC Office for Greenville County, South Carolina, in Plat Book "RR", at Page 125, and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the southerly side of Maria Louisa Lane at the joint front corner of Lots Nos. 11 and 12, and running thence with the joint lines of said lots S. 17-06 E. 148.8 feet to an iron pin; running thence S. 73-59 E. 48.9 feet to an iron pin; running thence N. 22-13 E. 158.6 feet to an iron pin on the southerly side of Maria Louisa Lane; thence with the southerly side of Maria Louisa Lane N. 76-35 W. 69.9 feet to an iron pin; thence continuing with the southerly side of said Lane S. 84-58 W. 83 feet to the point of BEGINNING.

Grantors are to pay 1968 County taxes.

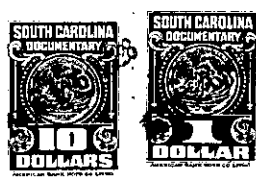
