the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto

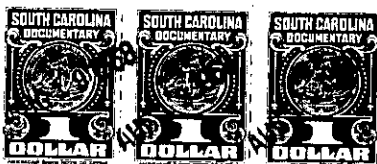
C. S. Mattox and Wilson M. Dillard, their heirs and assigns forever:

All that piece, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina on the southern side of Marlow Lane and being known and designated as Lot No. 160 on plat of Avon Park Subdivision recorded in the R. M. C. Office for Greenville County in Plat Book "KK", at Page 71 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern side of Marlow Lane at the joint front corner of Lots Nos. 160 and 161 and running thence along said Lane S. 69-51 W. 80 feet to an iron pin; thence along the joint line of Lots Nos. 159 and 160 S. 20-09 E. 256.5 feet to an iron pin; thence N. 83-34 E. 89.5 feet to an iron pin; thence along the joint line of Lots Nos. 160 and 161 N. 20-09 W. 216.5 feet to the point of beginning.
