ALL that piece, parcel or lot of land lying and being in the County of Greenville, State of South Carolina, being shown and designated as Lot No. 20 on the plat of Drexel Terrace, dated April 1, 1961, prepared by Piedmont Engineering Service, recorded in the Office of the R.M.C. for Greenville County in Plat Book QQ at page 177, and being more particularly described with reference to said plat as follows:

BEGINNING at a point on the northerly side of Rosebrier Lane, joint front corner of Lot Nos. 20 and 21 and running thence along the common boundary of Lot Nos. 20 and 21 N. 53-21 W. 147.5 feet to a point on a branch; thence along the branch as a line N. 17-32 E. 105.2 feet to the joint rear corner of Lot Nos. 19 and 20; thence along the common boundary of Lot Nos. 19 and 20 S. 51-49 E. 174.9 feet to a point on the northerly side of Rosebrier Lane; thence along the northerly side of Rosebrier Lane S. 32-21 W. 95.0 feet to the point of beginning.

Said lot is subject to protective covenants for Drexel Terrace recorded on April 7, 1961, in the Office of the R.M.C. for Greenville County in Deed Book 671 at page 355 and to building setback line as shown on said plat.

This is a portion of the property conveyed to the Grantor herein by deed of W. B. Simmons, recorded on April 3, 1961, in the Office of the R.M.C for Greenville County in Deed Book 671 at page 155.
