Dalton, Engineer, dated December, 1943, recorded in the R. M. C. Office for Greenville County, South Carolina in Plat Book "K" at page 276, and having the following metes and bounds, to-wit:

BEGINNING at a point on northwestern side of Fifth Street, joint front corner with Lot No. 70 and running thence N. 42-43 E. 98 feet along northwestern side of said Fifth Street, to point, joint corner with lot No. 72: thence N. 48-22 W. 252.6 feet along line of Lot No. 72, to point, joint rear corner, Lots Nos. 71, 72, 56 and 57: thence in a southeasterly direction, 251.4 feet along line of Lot No. 70 to the point of beginning.
