ALL water lines, mains, valves and appurtenances installed and located in, under and along Paris View Drive in or near Greenville, Greenville County, State of South Carolina including approximately 483 feet - 2 inch Galv. pipe and is shown on a drawing entitled "Henry L. Crumley to Piedmont Park Fire District," attached hereto and made a part of this conveyance.

TOGETHER with all other mechanical parts and equipment appurtenant to said lines and all rights of way and easements necessary or incident to the operation, maintenance, repair or replacement of said water lines and appurtenances.
