ALL that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, fronting on Ashley Avenue in the City of Greenville, S. C. as shown by a plat of J. H. Wilson property, made by J. Mac Richardson, Engineer, dated September 24, 1954, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on Ashley Avenue and running thence N. 0-45 E. 95.5 feet to iron pin; thence N. 80-15 W. 60 feet to iron pin; thence S. 9-45 W. 119 feet to iron pin on Ashley Avenue; thence with the said Ashley Avenue, N. 81-00 E. 63.5 feet to iron pin at point of beginning.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
