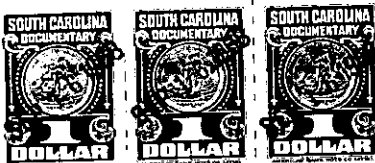
KNOW ALL MEN BY THESE PRESENTS, that I, Ansel Kellett

in consideration of Twelve Hundred (\$1200.00) Dollars
the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Nora C. Crosby, her heirs and assigns:

All that piece, parcel, or lot of land located in the State of South Carolina, County of Greenville, on the North-East side of the East Georgia Road, with the said land further shown on a plat prepared by C. O. Riddle, Registered Land Surveyor, designated as property of Ansel Kellett, and dated August 1968, and to be recorded. According to the said plat, the land herein conveyed has the following courses and distances:

BEGINNING, at an iron pin on the East Georgia Road, joint corner of property owned by the grantor and Thomas Holcombe and thence, N 38-01 W, and 286 feet to an iron pin; thence N 48-43 E and 479.1 feet to an iron pin; thence S 85-00 E. and 253. 4/10 feet to an iron pin; and thence S 40-02 W and 678.4 feet to the point of beginning. The tract contains 3.19 acres.
