**This conveyance subject to any right-of ways of records and Grantor will pay 1968 County taxes.**

**This conveyance made subject to the following restrictions and conditions to-wit:**

- 1. This said property is not to be sold by the Grantee at any time or to any person during the lifetime of the Grantor without the Grantor's consent and Grantor will by necessity also have to consent to any mortgage placed by Grantee on the property by waver of this particular restriction to a mortgagee.**
- 2. This property is to be used for residential purposes only until January 1, 2008.**
- 3. No residence shall be constructed on this property for a cost of less than \$10,000.00 with valuation of construction being determined on costs and economic conditions which exist at this time.**
- 4. No structures shall be placed on this property which shall have exposed cement block and all exteriors must be of brick other than trim work or decorating materials which might be of a different texture from brick.**
