All that certain piece, parcel, or lot of land, with all improvements thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot No. 191, Section 4 of a subdivision known as Colonial Hills, as shown on a plat thereof, prepared by Piedmont Engineers & Architects, dated October 20, 1967, recorded in the R. M. C. Office for Greenville County in Plat Book WWW, at Page 3, and having, according to said plat, the following metes and bounds, to-wit:
