All that piece, parcel and lot of land situate, lying and being in the county of Greenville, state of South Carolina, and being known and designated as Lot No. 2 on revised Map No. 1 of Franklin Hill subdivision made by C. O. Riddle in May of 1963 recorded in the RMC Office for Greenville County in Plat Book DDD page 95, and having according to said plat the following description:
