the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto

Willie F. Privette and Lois C. Privette, their heirs and assigns, forever:

ALL that piece, parcel or lot of land in Greenville County, State of South Carolina, being known and designated as Lot No. 120 as shown on a Plat of Chevy Chase dated July, 1963 by Dalton & Neves Engineers recorded in the R. M. C. Office for Greenville County in Plat Book YY, at Page 121, and having according to said Plat the following description, to-wit:

Lot 120 Chevy Chase Blvd., Chevy Chase:

BEGINNING on Chevy Chase Boulevard at an iron pin at joint front corners of Lots 121 and 120 and running thence 59.9 feet to an pin on said Boulevard; continuing with the curve of said Boulevard to another iron pin 80.8 feet at joint front corners of lots 120 and 119, according to said Plat; running thence 160.5 feet with the side line of lot 119 to an iron pin at joint rear corners of lots 119, 118, 120 and 121; running thence 175 feet with the side line of lot 121 to the iron pin at joint front corners of lots 121 and 120, on Chevy Chase Boulevard, the point of beginning.

NO residence to cost less than \$10,000.00 shall be erected on said lot; no residence shall be erected on any lot unless said lot has 70 feet, or more, frontage; no residence shall be erected on said lot nearer than 35 feet to the front line; all lots to be used for residential purposes, only, except lots fronting on Augusta Road; no outside toilets permitted and sewage to be disposed of by approved septic tanks.

THIS conveyance is subject to all easements and rights of way of record.
