the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto

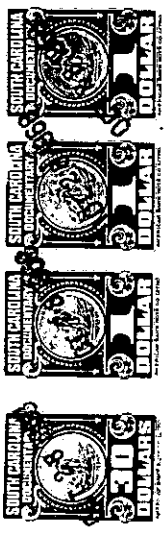
JERRY LEE STEWART and MARTHA JANET STEWART, their heirs and assigns, forever:
