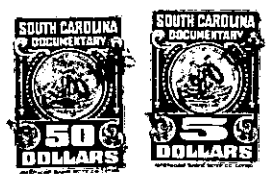
Know All Men by These Presents:

ALL that piece, parcel or lot of land in the City of Greenville, Greenville Township, Greenville County, State of South Carolina, located at the Northeast corner of the intersection of North Main Street and East Earle Street, and having, according to a plat entitled "Property of James Rigas", made by R. B. Bruce, R.L.S., April 17, 1964, the following metes and bounds, to-wit:
