Walter D. Wolfe and Elsie S. Wolfe, their heirs and assigns, forever:

ALL that piece, parcel or lot of land in the State and County aforesaid, being known and designated as Lot No. 22 Pinewood Drive as shown on a Plat of Pinewood Estates by H. S. Brockman, Surveyor, dated November 7, 1958 and recorded in the R.M.C. Office for Greenville County in Plat Book MM, at Page 55, and having according to said Plat the following description, to-wit:

BEGINNING on Pinewood Drive at an iron pin at joint front corners of Lots 21 and 22 and running thence 85 feet with the line of said Drive to an iron pin at joint front corners of lots 22 and 23; running thence 170 feet with the side line of lot 23 to an iron pin at joint rear corners of lots 22 and 23 and side line of lot 24; running thence 85 feet with the side line of lot 24 to an iron pin at joint rear corners of lots 21 and 22; running thence 170.3 feet with the side line of lot 21 to the iron pin at joint front corners of lots 21 and 22 on Pinewood Drive, the point of beginning.

NO residence to cost less than \$10,000.00 shall be erected on any lot; no residence shall be erected on lots nearer than 35 feet to the front line; no residence shall be built on any lot unless said lot has 70 feet, or more, frontage; no outside toilets permitted and sewage to be disposed of by approved septic tanks; all lots to be used for residential purposes, only.
