All that piece, parcel or lot of land in Butler Township, Greenville County, State of South Carolina, being known as Lot No. 39 Chisolm Trail, of Section 2, Parkins Lake Development near Greenville, S. C. according to a plat made October 22, 1962 by R. K. Campbell, Engineer, and recorded in the R. M. C. Office for Greenville County, S. C. in Plat Book "YY" Page 93 and being more particularly described as follows:

BEGINNING at an iron pin on the North Side of Chisolm Trail, joint front corner of Lots 38 and 39 and running along Chisolm Trail N. 33-55 E. 175 feet to an iron pin, joint front corner of Lots 39 and 40; thence along the line of Lot 40 N. 56-05 W. 175 feet to an iron pin, joint rear corner of Lots 39 and 40; thence S. 31-42 W. 175 feet to an iron pin, joint rear corner of Lots 38 and 39; thence along the line of Lot 38 S. 56-05 E. 170 feet to an iron pin, the beginning corner.

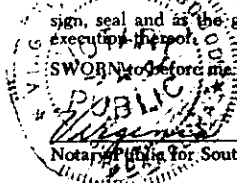
