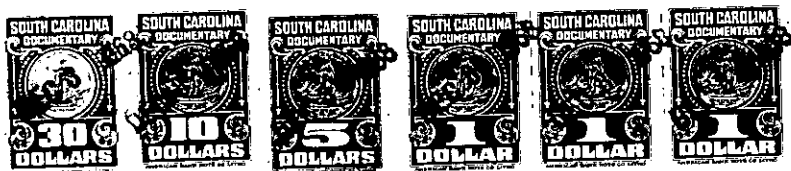
TOMMY L. BISHOP, HIS HEIRS AND ASSIGNS, FOREVER:
