ALL that piece, parcel or lot of land in Greenville County, South Carolina, being known and designated as Lot No. 215, Section III-B of Westcliffe Sub-division, as shown on a plat thereof prepared by Piedmont Engineers & Architects, December 11, 1963, revised September 24, 1965 and recorded in the R.
