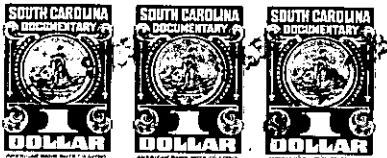

Mac Richardson, May, 1960, and recorded in the R.M.C. Office for Greenville County in Plat Book QQ, Page 143, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern side of Hartsville Street, joint front corner of Lots Nos. 221 and 222, and running thence along the joint line of said lots, S. 3-21 E. 160 feet to an iron pin on the rear line of Lot No. 146; thence along the line of that lot, N. 86-39 E. 90 feet to an iron pin at the rear corner of Lot No. 223; running thence N3-21 W. 160 feet to an iron pin on the southern side of Hartsville Street; thence along the southern edge of said Street S86-39W 90 feet to the point of beginning.
