KNOW ALL MEN BY THESE PRESENTS, that Olin Dean Willis

in consideration of One and no/100---(\$1.00)-----Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Richard Donald Willis, his heirs and assigns, all my right, title and interest, the same being a one-eighth undivided, interest in the following described property.

ALL that piece, parcel or tract of land containing 35.35 acres, more or less, situate, lying and being in Fairview Township, Greenville County, South Carolina on both sides of Terry Shop Road and having the following metes and bounds:

BEGINNING AT the intersection of Terry Shop Road and the old Fountain Inn-Fork Shoals Road and running along said Fountain Inn-Fork Shoals Road, N. 29 E. 118 feet to a point; thence continuing along said road, N. 68 E. 502.9 feet to a point in the center of said Road; thence along a line of property now or formerly belonging to W.A. Hopkins, S. 32 E. 347 feet to an iron pin; thence continuing along said Hopkins' property, N. 70 E. 147 feet to an iron pin; thence S. 80-45 E. 31.8 feet to an iron pin; thence N. 76-30 E. 248.7 feet to an iron pin; thence S. 44-34 E. 216 feet to an iron pin; thence S. 59-30 E. 344 feet to an iron pin; thence S. 40-30 E. 424.7 feet to an iron pin in the center of old Cedar Fall Road; thence N. 82-10 E. 145 feet to an iron pin; thence S. 41 E. 343 feet to an iron pin; thence S. 89-45 E. 128 feet to a Black Oak stump; thence S. 41-15 E. 311.5 feet to a double Black Oak; thence S. 64-15 E. 153 feet to a pine; thence S. 50-45 E. 232 feet to a poplar on branch; thence down branch, S. 5-20 W. 240 feet to an iron pin in center of Terry Shop Road; thence S. 63-30 E. 272 feet to an iron pin; thence S. 28-50 W. 706 feet to a stone; thence S. 51-40 W. 968 feet to a stone; thence S. 83-30 W. 167 feet to a stone at a joint corner of J. Meade Willis property; thence N. 41-30 E. 200 feet to a stake; thence N. 46-05 E. 785 feet to a stake in branch; thence along the branch as the line by the traverse lines as follows: N. 11-30 W. 81 feet to a point; thence N. 21-15 E. 371 feet to a point; thence N. 32-40 E. 235.5 feet to a stake in branch; thence leaving the branch and running N. 13-45 W. 61 feet to a stake on the edge of Terry Shop Road; thence along Terry Shop Road, N. 63-30 W. 1220 feet to a point at the intersection of Terry Shop Road and old Cedar Fall Road; thence continuing along Terry Shop Road, N. 63-30 W. 1894 feet to the beginning corner and being all of the property as shown on a plat of "Property of F. M. Willis", dated January, 1924, prepared by W. J. Riddle, Surveyor, and recorded in the RMC Office for Greenville County, South Carolina in Plat Book ZZZ, at page 115, except that portion of said property shown as a 40.30 acre tract on a plat of "Property of J. Meade Willis", dated April 22, 1946, prepared by W. J. Riddle, Surveyor, recorded in the RMC Office for Greenville County, South Carolina in Plat Book ZZZ, at page 113. This 35.35 acre tract was by F. M.
