ALL that certain piece, parcel or lot of land in Butler Township, Greenville County, State of South Carolina, near and East of the City of Greenville, and being known and designated as Lot Number 37 of a subdivision known as Terra Pines Estates Section 4, a plat of which is of record in the R. M. C. Office for Greenville County in Plat Book 000 at Page 85, and having the following metes and bounds, to wit:

BEGINNING at a point on the Northwestern side of Compton Drive at the joint front corner of Lots 36 and 37 and running thence with the Northwestern side of Compton Drive N 30-06 E 57 feet to a point; thence continuing with the Northwestern side of Compton Drive N 32-32 E 102 feet to a point; thence still continuing with the Northwestern side of Compton Drive N 37-25 E 102 feet to a point; thence still continuing with the Northwestern side of Compton Drive N 39-52 E 72 feet to a point at the joint corner of Lots 37 and 38; thence N 50-08 W 137.5 feet to a point at the joint rear corner of Lots 37 and 39; thence S 39-52 W 359.3 feet to a point at the joint rear corner of Lots 36 and 37; thence S 59-54 E 166.6 feet to a point on the Northwestern side of Compton Drive at the point of BEGINNING.

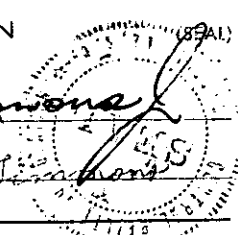
