KNOW ALL MEN BY THESE PRESENTS, that WE, PAUL F. FINLEY & SARA L. FINLEY

in consideration of Seven Hundred and No/100-----(\$ 700.00)----- Dollars  
AND ASSUMPTION OF MORTGAGE INDEBTEDNESS SET FORTH BELOW,  
the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release  
unto ERNEST L. CRANE and JULIA S. CRANE, their heirs and assigns forever:

ALL that lot of land with the buildings and improvements thereon, situate on the Southwest side of Nimitz Street near the City of Greenville in Greenville County, South Carolina, being shown as Lot No. 18 of PIEDMONT ESTATES, on plat thereof made by Dalton & Neves, Engineers, October, 1944, recorded in the RMC Office for Greenville County, S. C., in Plat Book M, page 123, said lot having according to said plat and a recent survey made by R. W. Dalton on December 27, 1956, the following metes and bounds, to wit:

BEGINNING at an iron pin on the Southwestern side of Nimitz Street at the joint front corner of Lots 17 and 18, and running thence with the line of Lot No. 17, S. 24-0 W., 200 feet to an iron pin; thence N. 66-0 W., 58 feet to an iron pin; thence with the line of Lot 19, N. 24-0 E., 200 feet to an iron pin on the Southwest side of Nimitz Street; thence with the said Nimitz Street, S. 66-0 E., 58 feet to the beginning corner.

The above described property is the same conveyed to the Grantors herein by deed recorded in the RMC Office for Greenville County, S. C., in Deed Book 833, page 603, and is conveyed subject to all restrictions, setback lines, easements, roadways, rights of way, if any, affecting the above described property.

As a part of the consideration for this deed, the Grantees assume and agree to pay the balance remaining due on a mortgage owned by Carolina National Mortgage Investment Co. in the original amount of \$6,450.00 dated December 1, 1967, recorded in the RMC Office for said County and State in Mortgage Book 1078, page 67, which has a present balance in the approximate sum of \$6324.73.

As a part of the consideration for this deed, the Grantors assign and transfer to the Grantees all their right, title and interest in and to any escrow deposits maintained by the above named mortgagee in connection with the mortgage loan covering the above described property.

The Grantees agree to pay Greenville County property taxes for the tax year 1969 and subsequent years.

And, the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s') heirs or successors, executors and administrators to warrant and forever defend all and singular said premises unto the grantee(s) and the grantee's(s') heirs or successors and assigns against the grantor(s) and the grantor's(s') heirs or successors and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
