KNOW ALL MEN BY THESE PRESENTS, that we, Charles Laten Styles, Alice Mae Lawrence Reid, Frankie L. Pittman, Larry Layton Lawrence and Mary Elizabeth Lawrence, in consideration of Ten Dollars (\$10.00) and love and affection, the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Alice Eaton all our right, title and interest in and to the below described real estate:

"ALL that piece, parcel or lot of land in Oneal Township, Greenville County, State of South Carolina lying on the south side of Pine Log Ford Road and containing twelve and one-half acres, more or less, and having the following metes and bounds:

BEGINNING at a point in center of Pine Log Ford Road located 496 feet along road from the center of Enoree River in a south-westerly direction also a corner of tract conveyed to Grantors, marked by iron pipe 25 feet on line, and running thence S. 33-45 E. 1197 feet to a large willow tree; thence S. 13-30 W. 70 feet to iron pipe by branch; thence N. 65-30 W. 246 feet to iron pipe on Laten Styles' line; thence S. 89-50 W. 248.4 feet to iron pin on Garner's line; thence N. 51-20 W. 581.7 feet to iron pin at corner of C. R. Pearson lot; thence N. 17-06 W. 320 feet over iron pin on bank of road to point in center of road; thence along Pine Log Ford Road as property line N. 57-00 E. 100 feet and N. 49-15 E. 396 feet to beginning corner."

This conveyance is made subject to any restrictions or easements that may appear of record, on the recorded plats or on the premises.

This tract of land is a part of the land formerly belonging to David H. Styles, deceased. See Deed Book III, Page 484 and Judgment Roll No. J-13, 181.
