Said premises being the same inherited by me from my brother, John P. Austin, and my mother, Lillian Allison Austin.

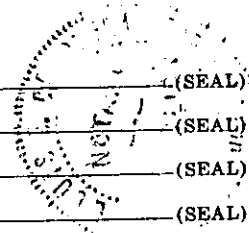

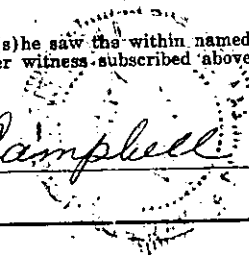

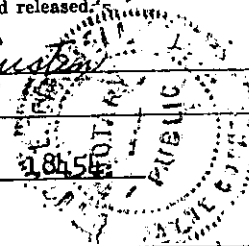
RENUNCIATION OF DOWER
