All that certain piece, parcel, or lot of land in the County of Greenville, State of South Carolina, on the northerly side of Sunnyview Drive, being shown and designated as Lot No. 38, on plat of Staunton Heights, prepared by C. C. Jones, CE, April, 1960, and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the northerly side of Sunnyview Drive at the joint front corner of Lots Nos. 37 and 38, and running thence with the joint line of said lots N. 12-28 E. 62.3 feet to an iron pin, joint rear corner of Lots Nos. 38 and 39; running thence with the joint line of said lots N. 83-35 E. 160 feet to an iron pin on the westerly side of Staunton Bridge Road; thence with the westerly side of said Road S. 6-25 E. 100 feet to an iron pin; thence on a curve, the chord of which is S. 42-52 W. 26.2 feet to an iron pin on the northerly side of Sunnyview Drive; thence with the northerly side of said Drive N. 88-20 W. 52.1 feet; thence continuing with said Drive N. 77-41 W. 50.4 feet; thence still continuing with said Drive N. 67-02 W. 70 feet to the point of BEGINNING.

This property is to be used for residential purposes only, and no residence shall be constructed on any lot having a reasonable market value for house and lot of less than Fifteen Thousand and No/100 (\$15,000.00) Dollars. No business shall be conducted on said lot.
