to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said grantee(s)

KENNETH L. LOFTIS AND FLORENCE S. LOFTIS, THEIR HEIRS AND ASSIGNS, FOREVER:

All that certain piece, parcel, or lot of land in the County of Greenville, State of South Carolina, on the southerly side of Maria Louisa Lane, being shown and designated as Lot No. 8, on plat of Dellvista Heights, recorded in the RMC Office for Greenville County, S. C., in Plat Book "RR", at Page 125, and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the southerly side of Maria Louisa Lane at the joint front corner of Lots Nos. 8 and 9, and running thence with the joint lines of said lots S. 30-58 W. 150 feet to an iron pin; running thence S. 59-02 E. 110 feet to an iron pin; running thence N. 30-58 E. 150 feet to an iron pin on the southerly side of Maria Louisa Lane; running thence with the southerly side of said Lane N. 59-02 W. 110 feet to the point of BEGINNING.

The within conveyance is subject to restrictions of record, and is also subject to utility easements and rights-of-way of record or on the ground.

As a part of the consideration, grantees assume and agree to pay the balance due on that certain mortgage from the grantor to First Federal Savings & Loan Association of Greenville, S. C., said mortgage being in the original amount of \$15,000.00, recorded 2 February 1968, RMC Office for Greenville County, S. C., in Mortgage Book 1083, at Page 184, upon which there is a present balance due of \$14,902.60.
