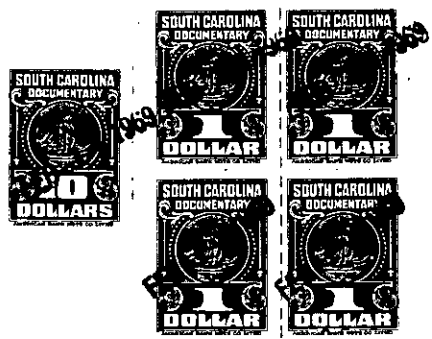
KNOW ALL MEN BY THESE PRESENTS, that ^{B.M.C.} McCall-Threatt Enterprises, Inc.
