ALL that piece, parcel or lot of land, with the buildings and improvements thereon, situate, lying and being near the City of Greenville, in the County of Greenville, State of South Carolina, being known and designated as the major portion of Lot No. 47,, Hudson Acres, which plat is recorded in the RMC Office for Greenville County, South Carolina, in Plat Book Y, page 39, and having according to said plat and also according to plat of property of Joe O. Charping S. 64-00 W. 194.8 feet to an iron pin on Hudson Drive; thence along Hudson Drive(now Rockmont Road) S. 69-20 E. 200 feet to an iron pin, the point of beginning.
