the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto

C. D. Czerwonka and Lona Czerwonka, their heirs and assigns, forever:

ALL that piece, parcel or lot of land in the State and County aforesaid, being known and designated as Lot No. 3 Casa-Loma Street, as shown on a Plat of Laurel Hills by W. N. Willis, Engineers, dated March 1960 and recorded in the R.M.C. Office for Greenville County in Plat Book RR at Page 33 and having according to said Plat the following description, to-wit:

BEGINNING on Casa-Loma Street at an iron pin at joint front corners of Lots 2 and 3 and running thence 79.3 feet with the line of said Street to an iron pin; continuing thence 6.9 feet with the line of said Street to an iron pin at joint front corners of Lots 3 and 4; running thence 159.7 feet with the side line of lot 4 to an iron pin at joint rear corners of lots 3 and 4; running thence, according to recorded Plat, 75 feet with the rear line of lot 3 to an iron pin at joint rear corners of lots 2 and 3; running thence 137.7 feet with the side line of lot 2 to the iron pin at joint front corners of lots 2 and 3 on Casa-Loma Street, the point of beginning.

NO residence to cost less than \$10,000.00 shall be erected on any lot; no residence shall be erected on lots nearer than 30 feet to the front line; no outside toilets permitted and sewage to be disposed of by approved septic tanks; all lots to be used for residential purposes, only.

THIS conveyance is subject to all easements and rights of way of record.
