to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said grantee(s)

FRANK J. FOWLER, HIS HEIRS AND ASSIGNS, FOREVER:

All that certain piece, parcel, or lot of land in the County of Greenville, State of South Carolina, on the north-easterly side of Pine Ridge Drive, being shown and designated as Lot No. 36, on plat of Section 2, Plat 1, Fresh Meadows, recorded in the RMC Office for Greenville County, S. C., in Plat Book "S", at Page 61, and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the northeasterly side of Pine Ridge Drive, joint corner of Lots Nos. 35 and 36, and running thence N. 45-30 E. 265 feet; thence S. 24-05 E. 86.4 feet; thence S. 45-30 W. 234.8 feet to point on Pine Ridge Drive; thence along Pine Ridge Drive, N. 44-30 W. 81 feet to the point of BEGINNING.

The within conveyance is subject to restrictions of record, and is also subject to utility easements and rights-of-way of record or on the ground.

As a part of the consideration, grantee assumes and agrees to pay the balance due on that certain mortgage from the grantors to C. Douglas Wilson & Co., said mortgage being in the original amount of \$12,950.00, recorded 20 January 1966, RMC Office for Greenville County, S. C., in Mortgage Book 1020, at Page 135, upon which there is a present balance due of \$12,368.30.

The grantors hereby transfer and assign to the grantee the insurance policy and escrow account in connection with the above loan.
