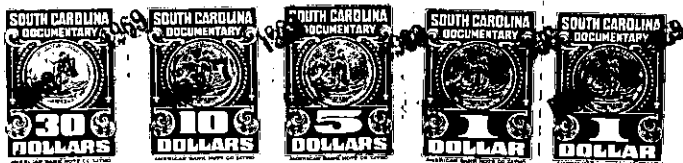
KNOW ALL MEN BY THESE PRESENTS, that Annie S. Wood -----
