This conveyance is made subject to the following restrictions:

- 1- No building is to be erected or used for commercial purposes on said lot, (Lots 1,2,3,4,5 and 6 im subdivision are designated for commercial purposes);
- 2- Any dwelling erected on said lot shall be at least 30 feet from any street on which it fronts, shall contain at least 1200 sq. ft. of floor space on the first floor, exclusive of poarches and garage; thall be equipped with a satisfacte .ory septic tank or connected to sewer;
- 3- No outbuildings with the exception of a garage shall be erected within 75 feet of any street on which lot fronts;
- 4- No pigs or goats are to be kept on said lot;
- 5- Any fences erected or used for the retention of animals other than domestic pets shall be at least 125 feet from any street on which lot fronts.
