CALVIN L. WATERS and SYLVIA L. WATERS, their heirs and assigns forever;

All that piece, parcel or lot of land in O'Neal Township, County of Greenville, State of South Carolina, located in Double Springs Community and on the Eastern side of a County road and having the following metes and bounds according to plat made for James H. Waters by John A. Simmons, surveyor, dated March 18, 1969, to wit:
