Know All Men by These Presents:

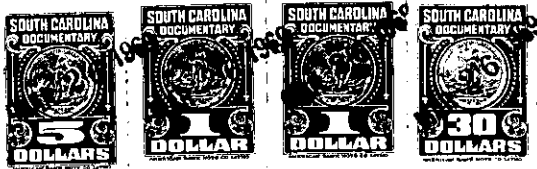

All that piece, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina, located at the intersection of Jervey Road and Dreamland Way, and having, according to plat of property of C. David Nutting and Jean Y. Nutting, prepared by Jones Engineering Services November 1968, which plat is recorded in the Office of the RMC of Greenville County in Plat Book 4A, at Page 133, the following metes and bounds, to-wit:

BEGINNING at an iron pin at the southern corner of the intersection of Jervey Road and Dreamland Way and running along Jervey Road S. 42-40 W. 100.3 feet to an iron pin; thence turning and running S. 30-00 E. 293.5 feet to an iron pin; thence turning and running N. 59-00 E. 143.4 feet to an iron pin on Dreamland Way; thence turning and running along Dreamland Way the following courses and distances: N. 13-21 W., 49 feet; N. 29-30 W., 50 feet; N. 41-12 W., 50 feet; N. 45-05 W., 50 feet; N. 47-37 W., 133.7 feet to the point of beginning.
