  those presently existing) to exist on, and from transferring, selling, assigning or in any manner disposing of, the real property described below, or any interest therein; and
- Herthy assign, transfer and set over to Bank, its successors and assigns, all monies now due and hereafter becoming due to the undersigned, as rental, or otherwise. and howsoever for or on account of that certain real property situated in the County of

Greenville \_\_\_\_, State of South Carolina, described as follows:

ALL that certain lot of land situate, lying and being in the State of South Carolina, County of Greenville at the Northwest corner of Spartanburg Road and Timberlake Drive near the City of Greenville being shown as Lot No. 47 on a plat of Section 1, Timberlake, recorded in Plat Book BB at Page 185 and being described as follows:

BEGINNING at an iron pin on the Northern side of Spartanburg Road at the corner of Lot No. 21 and running thence with the line of said Lot. N. 2-03 E. 207.85 feet to an iron pin at the corner of Lot No. 46; thence with line of said Lot, S.82-20 E. 180 feet to iron pin on the Northwestern side of Timberlake Drive; thence with said Drive, S. 7–40 W. 100 feet to a monument at the intersection of Spartanburg Road; thence with the curve of the intersection, the chord of which is S. 11-45 E. 41.7 feet to an iron pin on the Northern side of Spartanburg Road; thence with said Road, S. 70-23 W 154.6 feet to the beginning corner.

and hereby irrevocably authorize and direct all lessees, escrow holders and others to pay to Bank, all rent and all other monies whatsoever and whensoever becoming due to the undersigned, or any of them, and howsoever for or on account of said real property, and hereby irrevocably appoint Bank, as attorney in fact, with full power and authority, in the name of the undersigned, or in its own name, to endorse and negotiate checks, drafts and other instruments received in payment of, and to receive; receipt for and to enforce payment, by suit or otherwise, of all said rents and sums; but agrees that Bank shall have no obligation so to do, or to perform or discharge any obligation, duty or liability of the undersigned in connection therewith.

- 4. That if default be made in the performance of any of the terms hereof, or if any of said rental or other sums be not paid to Bank when due, Bank, at its election, may declare the entire remaining unpaid principal and interest of any obligation or indebtedness then remaining unpaid to Bank to be due and payable forthwith.
- 5. That Bank may and is hereby authorized and permitted to cause this instrument to be recorded at such time and in such places as Bank, in its discretion, may elect.
- 6. Upon payment of all indebtedness of the undersigned to Bank this agreement shall be and become void and of no effect, until then it shall apply to and bind the undersigned, their heirs, legatees, devisees, administrators, executors, successors assigns, and inure to the benefit of Bank and its successors and assigns. The affidavit of any officer or department manager of I showing any part of said indebtedness to remain unpaid shall be and constitute conclusive evidence of the validity, effectiveness continuing force of this agreement and any person may and is hereby authorized to rely thereon.
