After due notice served upon the above-named person, firm or corporation that a right-of-way would be condemned for the construction of <sup>File</sup> ~~Order~~ No. 23.566. Proj. U-086-1(51), between Survey Stations 2/81 and 3/36.5 on the left and right,

and compensation fixed and damages assessed therefor and after full hearing of all testimony and arguments and careful consideration of all questions involved.

Be it Resolved by this Board of Condemnation that, after taking into consideration the benefits accruing to the landowner by the construction or improvement of the highway, the value of the lands being taken together with any special damages occasioned by the construction or improvement of the highway and deducting the total value of the benefits from the total value of the damages in accordance with the statutes, the members

of this Board find that the damages exceeds the benefits and we therefore make an award of Ten thousand three hundred fifty and no/100 dollars (\$10,350.00) for approximately 5,825 s.f. of land, the frame residence, the frame shed, the portion of the Concrete Block Carport, and all improvements within the right of way and all damages, with fee simple title to the land and the improvements thereon as described in the Notice of Condemnation dated October 10, 1968.

The frame residence, the frame shed, the portion of the Concrete Block Carport and all improvements within the right of way become the property of and are to be removed or demolished by the State Highway Department. Any appeal by the landowner from this Award shall be served by mail or otherwise upon the Department within twenty days after the receipt of this Resolution in accordance with the provisions of Section 33-139.
