the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto PRUDENCE F. TRUE,

All that certain piece, parcel or lot of land in Butler Township, Greenville County, State of South Carolina, near and east of the city of Greenville, and being known and designated as Lot Number 1 of a subdivision known as Terra Pines Estates, Section 4, a plat of which is of record in the RMC Office for Greenville County in Plat Book 000 at page 85, and having the following metes and bounds, to-wit:

Beginning at a point on the southeastern side of Compton Drive at the joint front corner of Lots 1 and 2, and running thence with the southeastern side of Compton Drive S. 20-15 W. 125 feet to a point; thence continuing with the southeastern side of Compton Drive S. 35-48 W. 52.95 feet to a point; thence still continuing with the southeastern side of Compton Drive S. 66-56 W. 52.95 feet to a point at the joint corner of Lot 1 and a lot owned now or formerly owned by H. J. Martin and Joe O. Charping; thence S. 7-31 E. 175 feet to a point at the rear corner of Lot 1; thence N. 82-29 E. 88.3 feet to a point; thence N. 35-00 E. 236.4 feet to a point at the joint rear corner of Lots 1 and 2; thence N. 69-45 W. 193.3 feet to a point on the southeastern side of Compton Drive at the point of beginning.
