Heathwood Drive and Bedford Lane, near the City of Greenville, in the County of Greenville, State of South Carolina and known and designated as Lot No. 40 of a subdivision known as Heathwood, plat of which is recorded in the R.M.C. Office for Greenville County, in Plat Book KK at Page 35 and according to said plat has the following metes and bounds, to-wit:

Beginning at an iron pin on the southern side of E. Heathwood Drive at the joint front corner of Lots Nos. 40 and 41 and running thence with the southern side of said drive S. 80-60 E., 75 feet to an iron pin at the intersection of said drive and Bedford Lane which intersection is curved, the chord of which is S. 35-06 E., 35.3 feet to an iron pin on the western side of Bedford Lane; running thence with the western side of said lane S. 9-54 W., 175 feet to an iron pin at the joint corner of Lots Nos. 40 and 39 and running thence N. 80-06 W., 100 feet to an iron pin at the joint rear corner of Lots Nos. 40 and 41; running thence N. 9-54 E., 200 feet to an iron pin, point of beginning.
