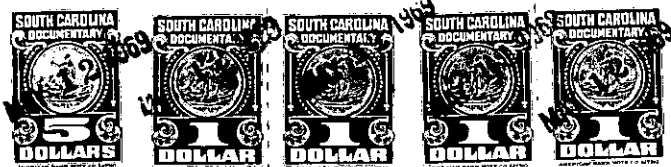

BEGINNING at the joint front corner of Lots No. 49 and 56 running thence along the line of said lots N. 1-29 W. 175 feet to the joint rear corner of said lots; thence S. 88-31 Southwest 110 feet; thence S. 1-29 E. 175 feet to Oakleaf Drive; thence along Oakleaf Drive N. 88-31 E. 110 feet to the beginning corner.
