All that certain piece, parcel or lot of land situate, lying and being in the State and County aforesaid, Oneal Township, about four miles north of Greer, S. C., lying on the north side of the Gap Creek Road, and being a part of tract No. 4 as shown on Plat of Property of S. D. Mosteller Estate made by J. H. Atkins, Surveyor, Sept. 1940 (Mill Tract), and being further shown as Lots Nos. 3 and 3-A, on Plat of Property of Egbert Mosteller Estate, made by H. S. Brockman, Surveyor, November 15th 1968, and having the following courses and distances, to wit:-

Beginning on an iron pin on the north margin of the said Gap Creek Road, joint corner of Lots Nos. 2 and 3 on the 1968 plat, and runs thence with the common line of the two lots, N. 31-33 E. 205 feet to an iron pin, joint corner of lots Nos. 2 and 3 and 2-A and 3-A; thence with the common line of Lots Nos. 2-A and 3-A, N. 15-36 E. 697.6 feet to an iron pin on the Gibson line; thence with the said line, N. 75-44 W. 30 feet to an iron pin on the said line and joint corner of Lots Nos. 3-A and 4-A; thence with the common line of Lots Nos. 3-A and 4-A, S. 23-21 W. 668.7 feet to an iron pin, joint corner of Lots Nos. 3-A, 4-A, 3 and 4; thence with the common line of Lots Nos 3 and 4, S. 31-33 W. 205 feet to an iron pin on the north margin of the Gap Creek Road; thence with the north margin of the said road, S. 58-27 E. 124 feet to the beginning corner, containing One and Seventy Seven one-hundredths (1.77) acres, more or less.
