to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said grantee(s) Lillian B. Quemere and her heirs and assigns forever:

All that certain parcel or lot of land containing 4.7 acres, more or less, situated on the west side of State Highway No. 23-S69, near Blue Ridge High School, Highland Township, Greenville County, State of South Carolina, and being Lot No. 2 of the property of Hartwell Beacham Estate, according to survey and plat by W. N. Willis, Engineers, dated March 25, 1969, and having the following courses and distances, to-wit:
