ALL that lot of land, in the State of South Carolina, County of Greenville, in Bates Township, known as Lot No. 87 of a Subdivision of Ray E. McAlister property, near Travelers Rest, South Carolina, and recorded in the R. M. C. Office for Greenville County in Plat Book S, Page 153, and having, according to said plat, the following metes and bounds, to-wit:
