the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Edwin F. Patterson, his heirs and assigns forever,

All my right, title and interest in and to:

All that piece, parcel or lot of land situate on the Western side of Bethel Road in the County of Greenville, State of South Carolina, being shown as Lot 1 on a plat of the property of W.F. Perrett dated June 13, 1947, prepared by J. C. Hill, Surveyor, recorded in Plat Book R at page 91 in the RMC Office for Greenville County and having according to said plat the following metes and bounds, to-wit:

BEGINNING at a nail in cap at the joint front corner of Lot 1 and Lot 2 and running thence with Lot 2, N. 39-15W. 896 feet to an iron pin at the joint rear corner of Lot 1 and Lot 2; thence S. 32-10W. 72 feet to an iron pin; thence S. 14-45E. 897.6 feet to an iron pin; thence S. 12E. 344 feet to an iron pin; thence S. 67-30E. 121 feet to a nail in a cap; thence N. 18-30E. 635.25 feet to the point of beginning.

This is the same property conveyed to Mattie P. Dorner by deed recorded in Deed Book 323 at page 360 in the RMC Office for Greenville County. The said Mattie P. Dorner died intestate on September 12, 1960, in Suffolk County, New York, leaving as her sole heirs at law her four children, Charles K. Dorner, Abina Dorner Davis, Efna Dorner Plaza, and Kobina Donald Dorner, Mattie P. Dorner's husband having predeceased her. The said Abina Dorner Davis died intestate on September 17, 1968, in Nassau County, New York; leaving as her sole heirs at law her husband, Sherman Davis, and two minor children, Rena B. Davis and Angela J. Davis. With the exception of the aforesaid two minor children, all of the heirs at law of Mattie P. Dorner and Abina Dorner Davis are sui juris.
