the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release
unto **Leon Moody, his heirs and assigns forever;**

ALL that piece, parcel or lot of land lying, being and situate on the West side of Earlene Drive about 1 mile North of Chick Springs, in County and State aforesaid, and being known and designated as lot no 57 of Pinewood Estates Subdivision as shown on plat prepared by H. S. Brockman, reg. Surveyor, dated Nov. 7, 1958 and which plat has been recorded in the R.M.C. Office for said County in Plat Book MM, page 55, and having the following courses and distances, to-wit:

BEGINNING at an iron pin on the West side of Earlene Drive at the joint front corner of lots nos. 56 and 57 as shown on said plat, and running thence with the joint property line of said two lots S 88-05 W 170 feet to an iron pin, thence S 1-55 E 92 feet to an iron pin at the joint rear corner of lots nos. 57 and 58 as shown on said plat, thence with the joint property line of said last two mentioned lots N 88-05 E 170 feet to an iron pin on the West side of Earlene Drive, thence with the West side of said Drive N 1-55 W 92 feet to the point of beginning. This being the same property conveyed to us in Deed Book 843, page 62.

NO residence to cost less than \$10,000.00 shall be erected on said lot; no residence shall be erected on said lot nearer than 35 feet to front line; no outside toilets permitted and sewerage to be disposed of by approved septic tanks; said lot shall be used for residential purposes only.
