the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto PAUL D. BRAMLETT & JUDY G. BRAMLETT, their heirs and assigns, forever:

All that certain piece, parcel or lot of land situate, lying and being in Bates Township, Greenville County, State of South Carolina, containing 5.10 acres, more or less, being shown on a plat of property of Grace Funk, Julia P. Center, Elizabeth Funk, dated May 24, 1969, surveyed by Terry T. Dill, Registered Civil Engineer and Land Surveyor, as the western portion of an 8.10 acre tract and having the following metes and bounds:

BEGINNING at an iron pin at the joint corner of the property herein conveyed and a 4.73 acre tract this day conveyed to John W. Grumbles and Sallie B. Grumbles, said iron pin is located S. 83-06 W. 1121.5 feet from an iron pin located in or near the right-of-way for U. S. Highway No. 25, other property now or formerly of Grantors herein, and property now or formerly of Nichols, running thence with the line of the 4.73 acre tract, herein above referred to, N. 10-58 E. 711.8 feet to an iron pin, joint corner of the 4.73 acre tract, a 7.97 acre tract and the property herein conveyed; thence with the line of the 7.97 acre tract S. 55-54 E. 290 feet to an iron pin; thence with the line of property this day conveyed to Lude S.
