

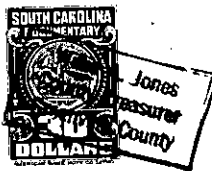

All that certain piece, parcel, or lot of land, situate, lying and being in
the State of South Carolina, County of Greenville, being known and designated as
Lot No. 5 of Block L, Section 5, of a subdivision known as East Highlands Estates
according to a plat thereof recorded in the R. M. C. Office for Greenville County
in Plat Book K, at Pages 79 and 80, and having, according to said plat, the following
metes and bounds, to-wit:

BEGINNING at an iron pin on the western side of Claremore Avenue at the
joint front corner of Lots Nos. 5 and 6, and running thence with the joint line of said
lots, S. 66-55 W. 175.5 feet to an iron pin on a 10-foot alley; and running thence along
