All that certain piece, parcel or lot of land in the County and State aforesaid, near the City of Greenville, in the subdivision known as "Kanatelah", situate on the south side of Oregon Street, known and designated as Lot No. 8 of Block "B" on plat of the said property recorded in the R. M. C. Office for said County in Plat Book "F", at Pages 66-67. The said lot has the following metes and bounds:
