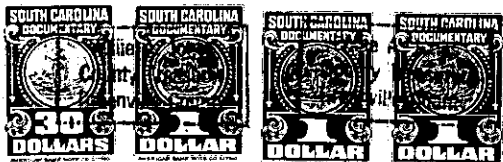
in consideration of Sixteen Thousand, Five Hundred and No/100-----(\$ 16,500.00)----- Dollars,

Bates; thence with the line of said property, S. 17-01 E. 149.4 feet to an iron pin at the joint rear corner of Lots 127 and 128; thence with the joint line of said lots, N. 71-32 E. 319 feet to an iron pin on the western side of West Drive, joint front corner of Lots 127 and 128; thence with the western side of West Drive, N. 18-25 W. 150.6 feet to the point of beginning; being the same conveyed to me by Stanley I.
